

**ANNUAL APPROPRIATION ORDINANCE
CITY OF MARSING
ORDINANCE A - 235**

AN ORDINANCE ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2024 APPROPRIATING THE SUM OF \$6,347,715.00 TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF MARSING FOR SAID FISCAL YEAR, AUTHORIZING A LEVY OF A SUFFICIENT TAX UPON THE TAXABLE PROPERTY AND SPECIFYING THE OBJECTS AND PURPOSE FOR WHICH SAID APPROPRIATION IS MADE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MARSING, OWYHEE COUNTY, IDAHO.

SECTION 1: That the sum of **\$6,347,715.00** be, and the same is appropriated to defray the necessary expenses and liabilities of the City of Marsing, Owyhee County, State of Idaho for the fiscal year beginning October 1, 2024.

SECTION 2: The objects and purposes for which such appropriation is made, and the amount of each object and purpose is as follows:

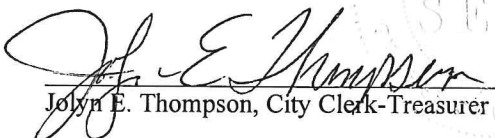
SECTION 3: That a general tax levy on all taxable property within the City of Marsing be levied in an amount allowed by law for general purpose for said City, for the fiscal year beginning October 1, 2024.

SECTION 4: All Ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed.

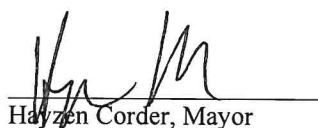
