Mayors Report:


1. Business Licenses Application: Chad Sevy's Painting Motioned by Councilman R. Percifield seconded by Councilman Even, all agree motioned passed

shops in town. Motioned as stated by Councilman Herman seconded by Councilman R. Percifield all agree motion passed.


