Council Meeting Minutes
March 11, 2020

Mayor Chad Sevy called the meeting to order at 7:00pm and led the Pledge of Allegiance.

5. Asked Philip to get opinions for Jetter trailer.


Mayors Report:

3. Paul Collins Snake River water trail – Camping overnight in July 1, 2020 Motioned by Councilman Even 2nd Councilman Malmberg all agree motioned passed.
4. Ashley Houweling White House Drive in Business license application Motioned by councilman Even 2nd Councilman R. Percifield all agree motion Passed Councilman Even brought up 2 trailers in back of White House Drive In. Council granted 6m for the occupants to find new place starting April 1, 2020. Can readdress in Oct, 2020.


