Owner of the dog and the owners of the property were noticed about the declaration and given the details of the meeting for appealing the decision. Maricruz Rodriguez, owner of the property came to appeal the decision. Leah Nemeroff, MSBT Law, swore Officer Townsend in and asked questions regarding the incident and report. Council also asked questions. Council asked Ms. Rodriguez questions and she added her own testimony and testimony on behalf of the dog owner. Councilperson Brandy Johnson motioned to dismiss the Dangerous Dog, Councilperson Chris Even seconded. All in favor, motion passed
